## EASEMENT

GEORGE STAHELI and AGNES STAHELI, his wife, and J. CLARK ELMER and NORMA ELMER, his wife, grantors of Payson, Utah County, Utah, for One Dollar and other valuable consideration, hereby convey and warranty unto RUFUS ROSS HUFF and WANDA S. HUFF, his wife, of Payson, Utah County, Utah, grantees, the right of way to maintain, operate, repair and replace the pipe line for the transportation of water on, over and through our lands, in the manner in which the pipe line presently exists and is located. The right of way shall be over and through the following described land with the right of ingress and egress to and from the pipe line:

Land of J. <sup>CLARK ELMER</sup> Elmer Clark: Commencing 23 chains East of the center of Section 16, Township 9 South, Range 2 East, Salt Lake Base and Meridian; thence North  $16\frac{3}{8}^{\circ}$  West 11.14 chains; thence West 4.85 chains; thence Southeast along the canal 11.58 chains; thence East 2.09 chains to the beginning.

Land of George Staheli: Commencing 23 chains East of the center of Section 16, Township 9 South, Range 2 East, Salt Lake Base and Meridian; thence North  $16\frac{3}{8}^{\circ}$  West 8.83 chains; thence South  $46^{\circ}$  East 12.2 chains; thence East 6.2 chains to the place of beginning.

The said grantors, GEORGE STAHELI and AGNES STAHELI and J. CLARK ELMER and NORMA ELMER, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said RUFUS ROSS HUFF and WANDA S. HUFF, who hereby agree to pay any damages which may arise to crops and fences from the maintaining or replacing the said pipe line.

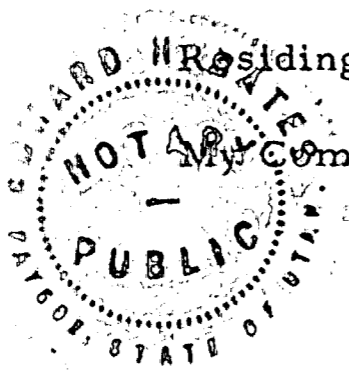
