## BASEMENT CONTRACT

CALVIN T. GRANT and wife REMEE N. GRANT, Grantors of Weber County,

State of Utah, hereby WARRANT AND CONVEY unto OGDEN CITY, a Municipal Corporation of the State of Utah, Grantes, an easement and right-of-way for the
construction of a water line across the Grantors! land situated in Weber County

State of Utah, to-wit:

A perpetual easement and right-of-way twelve (12) feet wide, the same being parallel and adjacent to, and on the westerly side of the following described line, to-wit:

A part of the South half of the Northwest Quarter of Section 31, T6N, RlW, S.L.B. & M. Beginning at a point on the West line of MHW Avenue 284.5 feet North of the North line of Kershaw Street and running thence N. 31° 57' W. 314.3 feet more or less to the Grantors' North property line. (Said line coincides with the westerly right-of-way line of Highway I-15)

This conveyance being executed for and in consideration of the sum of One Dollar (\$1.00) in hand paid to said Grantors by the said Grantee, Ogden City, the receipt of which is hereby acknowledged. It is understood and agreed that the payment of the above stated consideration is in full payment, compensation and settlement of and for all damages to crops, trees, shrubbery and property which may be destroyed or injured by reason of the use of said easement and right-of-way for the construction of said water line as well as for the easement and right-of-way itself.

It is expressly understood and agreed that Ogden City, after laying the said water line, shall cause the excavation to be backfilled, the pipe line covered, and remove from said premises and right-of-way all excess dirt and overburden, leaving the said premises in as nearly the original condition as practicable.

And it is further understood and agreed that the said Grantee, Ogden City, shall have the right of ingress and egress to and from said twelve (12) foot perpetual easement and right-of-way at any and all times for the purpose of inspecting, maintaining or repairing said water line.
