FIRST AMENDMENT TO THE AMENDED & RESTATED DECLARATION COVENANTS, CONDITIONS AND RESTRICTIONS FOR DEER VISTA

This FIRST AMENDMENT TO THE AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR DEER VISTA (the "First Amendment") is adopted, made, and executed this with day of January, 2020 by Deer Vista, LLC, a Utah limited liability company ("Declarant"). This Amendment shall apply to the real property (the "Property"), a subdivision situated in Wasatch County, Utah, commonly known as "Deer Vista Subdivision" and further described in Exhibit B attached hereto, for the mutual benefit of all current and future Owners, Guests, Residents, Mortgagees and other holders of an interest in the Property.

RECORDING ONLY

RECITALS

- A. WHEREAS, on August 4, 2015, Declarant recorded that Amended and Restated Declaration of Covenants, Conditions and Restrictions for Deer Vista (the "**Declaration**") with the Wasatch County Recorder, as Entry No. 414661, in Book 1136, at Pages 260 430;
- B. WHEREAS, the Property's subdivision plat has been recorded in phases: Phase One was recorded with the Wasatch County Recorder on February 24, 2005, as Entry No. 280208 in Book 737, at Pages 767 806; Phase Two was recorded with the Wasatch County Recorder on October 9, 2005, as Entry No. 290117, in Book 793, at Pages 221 240; Phase Three was recorded with the Wasatch County Recorder on October 9, 2005, as Entry No. 290118, in Book 793, at Pages 241-270 (collectively the "Plat");
- C. WHEREAS, Declarant incorporated Deer Vista Preserve Homeowners Association (the "Association"), a Utah non-profit corporation under the auspices of the Utah Revised Nonprofit Corporation Act, Utah Code Section 16-6a-101, et, seq., and the Utah Community Ownership Act, Utah Code Section 57-8a-101, et. seq.
- D. WHEREAS, Declarant formed the Association to, among other things, enforce the terms, conditions, restrictions and easements provided for in the Declaration and to govern, maintain and manage the Common Areas and Facilities of the Property further described in Exhibit A;
- E. WHEREAS, Section 22 of the Declaration provides that so long as Declarant owns at least fifteen (15) Lots in the Property or until the Declarant's Administrative Control terminates, Declarant may unilaterally amend or revoke the Declaration for any purpose;

- F. WHERAS, Declarant owns at least fifteen (15) Lots in the Property and Declarant's Administrative Control has not terminated;
- G. WHEREAS, these broad powers to amend the Declaration are further explained in Section 3 of the Declaration, providing that Declarant has the authority to unilaterally record supplemental Declarations and amendments to the Declaration against the Property as the Declarant determines to be appropriate and reasonably necessary for the Project so long as the Declarant owns any Lot or other real property in the Project;
 - H. WHEREAS, Declarant owns Lot(s) and other real property in the Project;
- I. WHEREAS, Declarant hereby exercises its unilateral right to execute and record this First Amendment for the purposes of amending the Declaration to include a Reinvestment Fee section, which is being enforced by the Board of Trustees of the Association; and
- J. WHEREAS, this First Amendment and the Declaration may hereinafter be collectively referred to as the "Declaration."

NOW, THEREFORE, Declarant hereby declares, covenants, and agrees as follows:

AGREEMENT

- 1. <u>Defined Terms</u>. Capitalized terms used and not otherwise defined in this First Amendment shall have the meaning or meanings given to them in the Declaration.
- 2. <u>Status of Recitals.</u> The Recitals set forth above shall constitute a portion of the terms of this First Amendment.
- 3. Addition of New Sections 1 (aaa) (ccc). Section 1 of the Declaration is amended to include the following language:
 - (aaa) <u>Burdened Lot</u>. Each Lot which is subject to the Reinvestment Fee Covenant described herein at Section 10 (b), and for which the Reinvestment Fee shall be dedicated to benefit.
 - (bbb) Reinvestment Fee. A maintenance fee, charge, or expense charged by the Association to be paid by a either a buyer purchasing or an Owner selling a Lot in the Project, upon and as a result of, a transfer of the Lot as described in Section 10 (b).
 - (ccc) <u>Transfer</u>. Each transfer, conveyance, closing, or settlement of the sale of a Lot located within the Property.

- 4. <u>Amendment to Section 10</u>. Section 10 of the Declaration is hereby deleted in its entirety and replaced with the following:
 - 10. <u>MEMBERSHIP IN THE ASSOCIATION; REINVESTMENT FEE COVENANT.</u>
 - (a) <u>Membership in the Association</u>. Since membership in the Association is mandatory, each Owner is a Member of the Association and membership may not be partitioned from ownership of a Lot.
 - (b) Reinvestment Fee Covenant; Reinvestment Fee Due upon Sale, Conveyance, or Transfer. The Association shall impose a Reinvestment Fee upon the close of the sale, transfer, or conveyance of any Lot (or interest therein). This covenant is intended to run with the land and to bind successors in interest to Lot in the Property and their assigns thereof, and shall extend for the duration of this Declaration as more particularly described in this section.
 - (i) The Reinvestment Fee shall be dedicated to benefitting a Burdened Lot, including payment for, but not limited to, common planning, facilities, and infrastructure; obligations arising from an environmental covenant; community programming; resort facilities; open space; recreation amenities; charitable purposes; Association Expenses; and/or any other purpose identified herein or in Utah Code Section 57-1-46(1)(i), as amended.
 - (ii) At the time of a Transfer, a Reinvestment Fee shall be paid to the Association by a buyer who is purchasing or an Owner who is selling, conveying or transferring a Lot.
 - (iii) The Board shall determine the sum of the Reinvestment Fee which shall not exceed .5% of the value of the Burdened Lot or that maximum threshold provided for in Utah Code Section 57-1-46, as amended, and be consistent with its intended purposes, which may be amended from time to time.
 - (iv) The Reinvestment Fee shall not be considered a transfer fee or "Transfer Fee Covenant" as that term is defined by Utah Code Section 57-1-46(1)(j).
 - (v) The existence of this covenant precludes the imposition of any additional reinvestment fees on the Burdened Lot.
 - (vi) For purposes of this Section and interpreting Section 10 (b)(i) above, the phrase "common planning, facilities, and infrastructure," shall be liberally and broadly construed to include any and all property and

Improvements included in the maintenance, repair, and/or replacement responsibility of the Association.

- (vii) The Reinvestment Fee is to be paid to the Association under the auspices of this Reinvestment Fee Covenant and shall benefit the Burdened Lot.
- (viii) The Reinvestment Fee shall not be enforced upon: (1) an involuntary Transfer; (2) a Transfer that results from a court order; (3) a bona fide Transfer to a family member of the seller within three degrees of consanguinity who, before the Transfer, provides adequate proof of consanguinity to the Association; (4) a Transfer or change of interest due to death, whether provided in a will, trust, or decree of distribution; (5) the Transfer of a Lot by a financial institution; or (6) the Declarant or first buyer of a Lot or Parcel from the Declarant.
- (ix) The Reinvestment Fee shall likewise not be enforced upon a Lot Transfer in which an Owner caused the construction of a Dwelling (the "Spec Home") on that Lot as a speculative venture for the Owner with the intention of selling the Spec Home for a profit. The Reinvestment Fee exclusion in this Section shall only apply to a Transfer in which no Person has occupied Spec Home. Occupied used in this Section shall liberally and broadly construed to include any and all residential occupancies, including primary residences, secondary residences, vacation rental, or long-term rental.
- (x) As mandated by Utah Code Section 57-1-46(6) to effectuate this covenant, on even date herewith, Declarant recorded with the Wasatch County Recorder a *Notice of Reinvestment Fee Covenant*, as Entry No. ____ in Book ___ at Page ___. A true and correct copy is attached hereto as **Exhibit C** and incorporated by reference.
- 5. <u>Binding Provisions</u>. The provisions of this First Amendment shall be binding upon all persons having right, title or interest to a Lot more properly described at Exhibit A, or any part thereof, their heirs, successors, and assigns and shall inure to the benefit of each Lot Owner thereof.
- 6. <u>Declaration and Bylaws Remain in Effect</u>. This First Amendment shall be considered supplemental to the Declaration. Except as expressly amended herein, the Declaration shall remain in full force and effect and shall not be cancelled, suspended, or otherwise abrogated by the recording of this First Amendment.
- 7. <u>Effective Date</u>. This First Amendment shall be effective as of the date of its recordation in the official real property records of the Recorder in and for Wasatch County, Utah.
