PETITION TO AMEND DECLARATION
OF PROTECTIVE COVENANTS, AGREEMENTS,
RESTRICTIONS AND CONDITIONS AFFECTING
THE REAL PROPERTY KNOWN AS EASTRIDGE V

COMES NOW the following property and home owners of Eastridge V. sub-
division and file the following petition to amend the declaration of protective
covenants, etc., filed against said subdivision in the office of the Salt Lake
County Recorder on the 7th day of April 1986 in Book 5753 at Page 632, etc.

SAID petition amends paragraph B-3 of said declaration by increasing the
total area of all the levels of the main structure of the building, exclusive
of one story open porches, and garages to not less than three thousand (3000)
square feet, finished or unfinished, whether one story or more. Further, said
petition amends paragraph B-3 of said declaration, to include "tri-level" or
"multi-level" dwellings, which shall be not less than 1,700 square feet on the
top two levels, shall not be less than 1,500 square feet for a one-story dwelling,
nor less than 2,000 square feet for a dwelling of more than one story above the
curb level.
