SUPPLEMENTAL EASEMENT

Aldo Jenö Prevedel and Rena R. Prevedel

his wife, Grantor s, for and in consideration of Fifteen and No/100 - - Dollars, and other valuable consideration, receipt of which is hereby acknowledged, do we hereby grant, bargain, sell, convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, Grantee, its successors and assigns, a perpetual easement and right of way for the construction, erection, operation and continued maintenance, repair, alteration, inspection, relocation, and/or replacement of a wood pole or steel tower line or lines for the transmission, distribution, telegraph and telephone circuits of the Grantee, and one tower structure(s) together with necessary cross-arms and attachments, with no guys including stubs and anchors, affixed thereto, for the support of said circuits, in, upon, along, over, through, across and under a tract of land 150 feet in width, situated in the County of Weber, State of Utah, particularly described as follows:

Beginning at a point 875 feet west of the 1/4 section corner between section 3, T. 5 N., R. 2 West, and section 34, T. 6 N., R. 2 West, S.L.B. & M., and running thence S. 0° 08' West a distance of 800 feet, more or less, thence East a distance of 150 feet, more or less, thence N. 0° 08' East a distance of 800 feet, more or less, thence West a distance of 150 feet, more or less, to the place of beginning, being all in the NE 1/4 of the NW 1/4 of section 3, T. 5 N., R. 2 West, S.L.B. & M.

This easement constitutes a grant of the right to construct a second transmission line within the above-described tract of land parallel to an existing transmission line; and this easement is granted in accord with and supplements a prior easement dated June 4, 1913, and recorded in the office of the County Recorder of Weber County, Utah, in Book H of Leases at page 514.

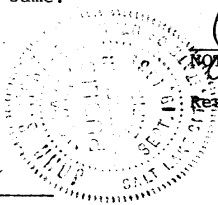
