ORDERED, ADJUDGED AND DECREED that Plaintiff shall have a Judgment against Defendant, Connie Tao, as follows:

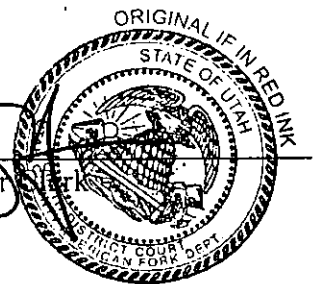

3. For a reasonable attorney's fee in the sum of \$700.00 pursuant to Rule 73 of the Utah Rules of Civil Procedure

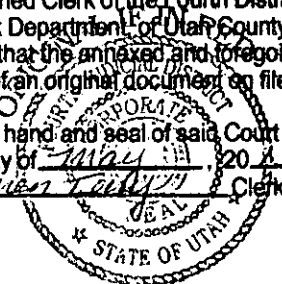
