POLE LINE EASEMENT

THE GEO. D. CARDON CO., INC., a corporation doing business in the State of Utah, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and one pole, with the necessary guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and mainted upon and across the premises of the Grantor, in Weber County, Utah, along a line described as follows:

Beginning on the South boundary line of grantor's land at a point 1726 feet East and North 1°26' East 642 feet, more or less, from the Southwest corner of Section 30, Township 6 North, Range 1 West, Salt Lake Base and Meridian, thence running North 1°26' East 380 feet, more or less, to North boundary line of said land.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
