Warranted Deed

I, Francis S. Bascom, of Salt Lake City and County grantor hereby convey and warrant to Anna S. B. Bascom, of Salt Lake City and County grantee for the sum of One (\$1.00) Dollars, the following described tract of land in Salt Lake County, Territory of Utah: that certain piece or parcel of land situate, lying and being in the City and County of Salt Lake, Utah. See viz: Commencing at a point ten (10) feet North from the South west corner of Lot five (5) in Block forty (40) in Plat "A" Salt Lake City survey and running thence East ten (10) rods, thence North Sixty nine and one half (69 1/2) feet, thence West ten (10) rods, thence South Sixty nine and one half (69 1/2) feet to place of beginning.
