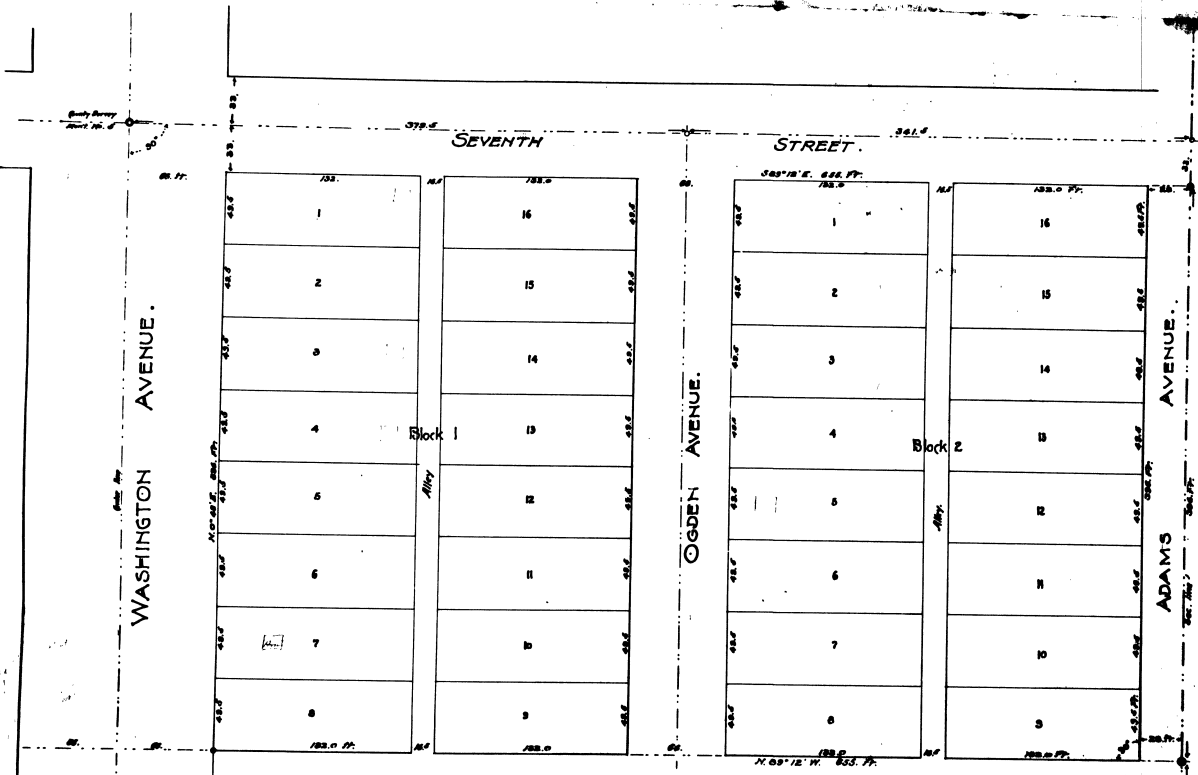

Dedication.

We the undersigned, hereby certify that we own the corners of the following described tract of land, to wit: Part of the South East Quarter of Section 26, 1/4 in Township 6 North, Range One West of Salt Lake Meridian, U.S. Survey, beginning at a point on the Section line 700' 1/2 North 0° 00' East from the South East Cor. of the said quarter Section, thence North 00° 12' 00" 65.50 feet to the East line of Washington Avenue, thence North 0° 00' East 220 feet along the East line of Washington Avenue to the South line of 7th Street, thence South 0° 00' East 220 feet along the South line of 7th Street to the East line of said quarter Section, 1/4 thence South 0° 00' West 220 feet along the Section line to the place of beginning.

We hereby dedicate said land and interest therein to the City of Ogden, Utah, as public thoroughfare for the use and enjoyment of the Myers' Addition, as public thoroughfare for the use and enjoyment of the adjoining lands.

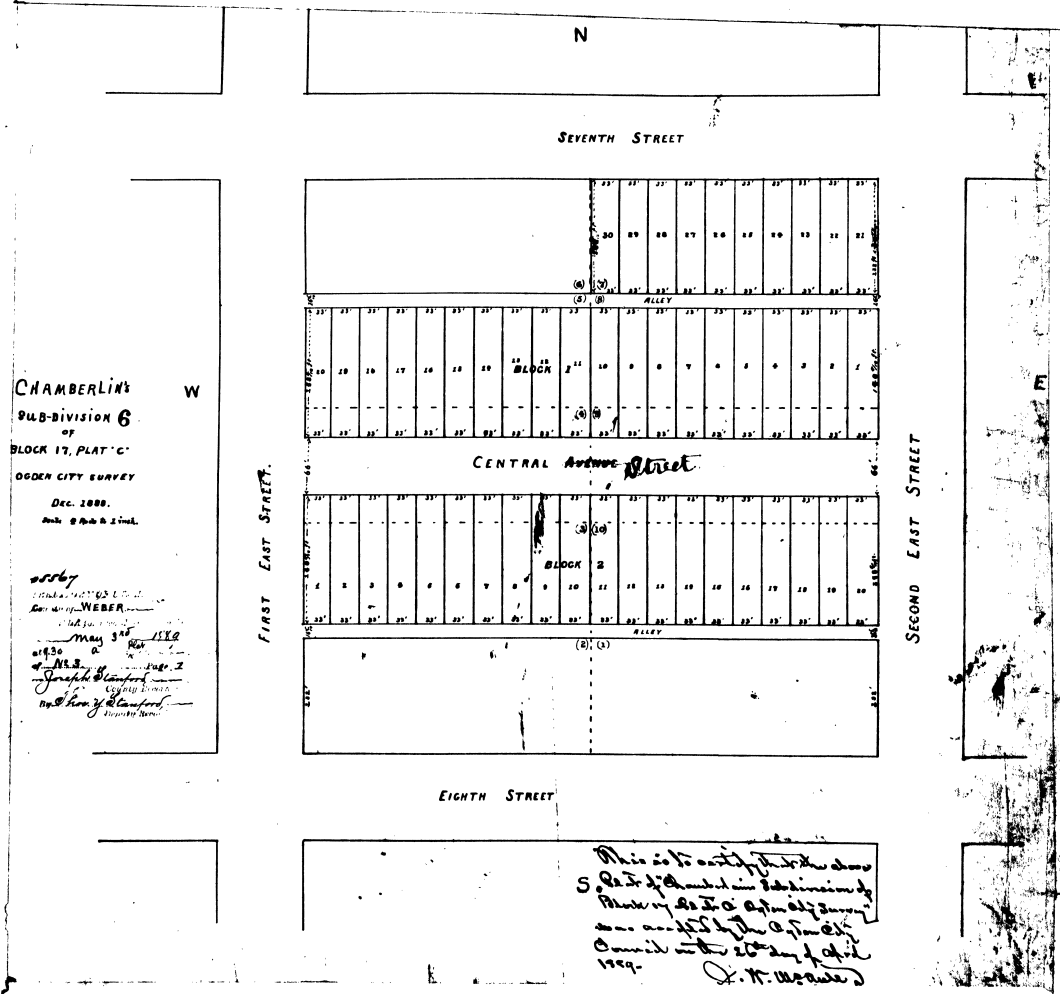
