Crowther, his wife, Grantors, do hereby convey and warrant to PacifiCorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of Ten (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and poles and guy anchors, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Salt Lake County, Utah, described as follows:

A right of way over the east 4 feet on the Grantor's land, being 4 feet west of and adjacent to the following described east boundary line of said Grantor's land:

Beginning at a southeast corner of the Grantor's land, said corner also being the southeast corner of Lot 8, Block 46, Plat A, Salt Lake City Survey, thence North 132 feet, more or less, along the east boundary line to a northeast corner of said land and being in said Lot 8; containing 0.012 of an acre, more or less.
