### AMENDMENT TO EASEMENT

This Amendment to Easement ("Amendment") is entered into between CHARLES W. NELSON as Trustee of the Nelson Family Trust, Grantor, and Rocky Mountain Power, an unincorporated division of PacifiCorp, its successors and assigns, Grantee.

### RECITALS

- A. Whereas on April 12, 1962, a perpetual easement was granted to Utah Power & Light Company, a corporation, its successors in interest and assigns, by Ralph Miller, Sr. and Grace Genevieve Miller, for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution and telephone circuits of the Grantee. Said easement is recorded on August 8, 1962 as Entry Number 298116, Book 110 of Page 208 in the Grand County Recorder's Office.

By this Amendment, Grantor and Grantee hereby desire to amend the number of two-pole structures on the property.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Grantor and Grantee agree as follows:

1. Grantor and Grantee hereby amend the language of the agreement to increase the number of TWO-POLE STRUCTURES from three to FOUR (4) on and over the real property of Grantor in Grand County, State of Utah more particularly described on Exhibit "A" attached hereto and by this reference made a part hereof.

2. Except as expressly set forth herein, all other terms and conditions of the Original Easement(s) shall remain in full force and effect.

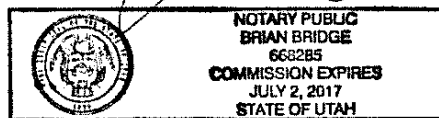

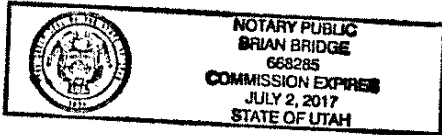

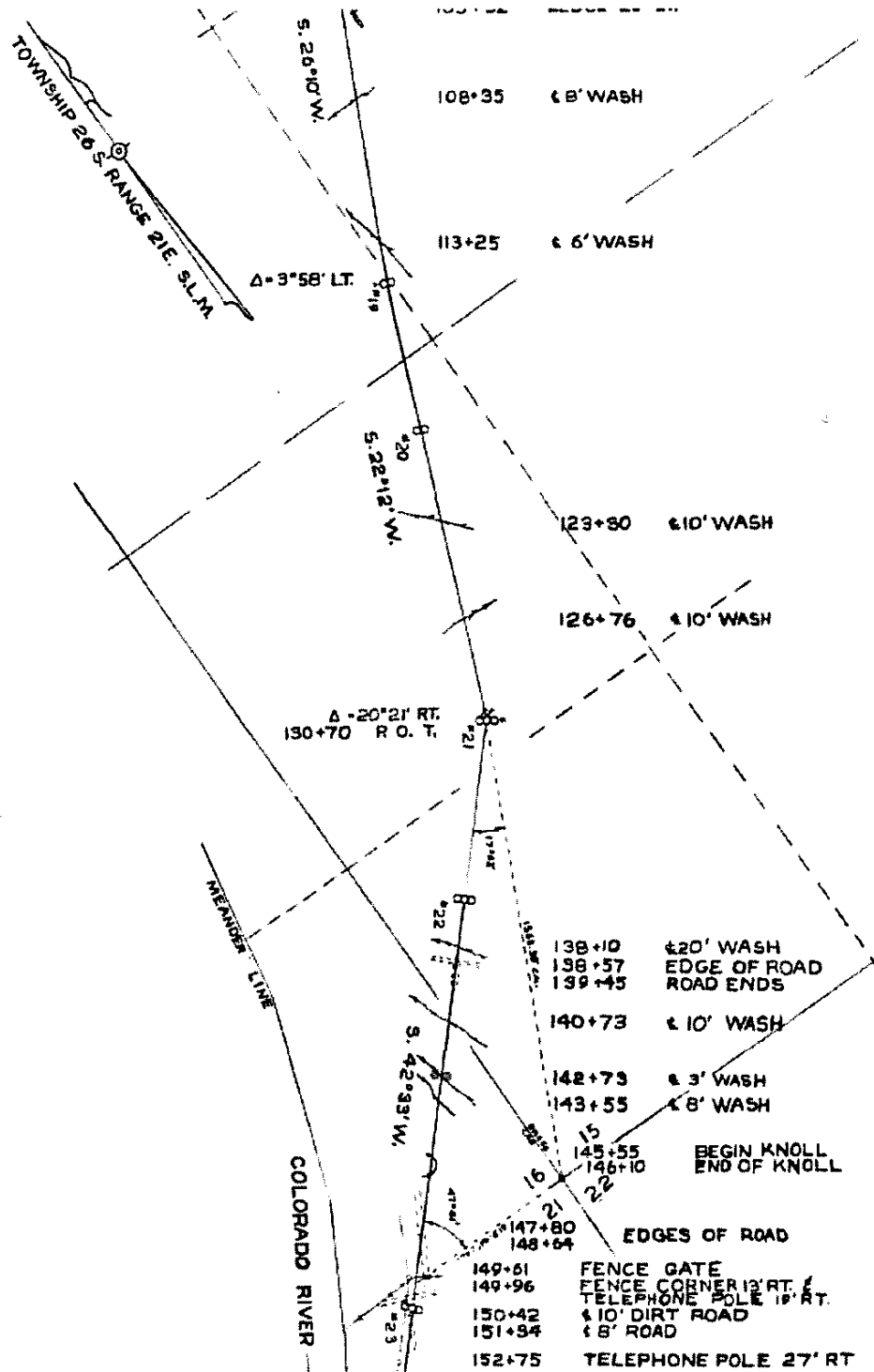
