CERTIFICATE OF ENCUMBENCY AND ALLOCATION OF REAL PROPERTY

EDNA B. OGDEN, STEVEN DALE OGDEN and LINDA ELIZABETH CALLAWAY, hereinafter referred to as "affiants," each being first duly sworn, on oath, depose and say:

- 1. That affiants are over the age of 18 years and are residents of the State of Utah and California, respectively;
- 2. That DALE R. OGDEN, is the husband and father of affiants, respectively; that up until the date of his death, said DALE R. OGDEN was a grantor and trustee of a certain trust agreement entitled "The Dale R. Ogden Family Inter Vivos Revocable Trust Agreement" which was dated and signed October 5, 1979; that DALE R. OGDEN died on February 9, 1992, at 2051 So. Tonaquint Drive, St. George, Utah; that DALE R. OGDEN conveyed an interest in the below described real property into the above-mentioned Trust (said conveyance made with a Quit Claim Deed being dated and signed August 20, 1991, and notarized August 21, 1991, and recorded September 6, 1991, in Book 6353 of deeds, Page 2318, Entry No. 5122654, Salt Lake County Recorder's Office); that DALE ROSS OGDEN named as the deceased in the certified copy of the death certificate hereto attached, incorporated herewith, and expressly made a part hereof, was one and the same

person as the DALE R. OGDEN named in said conveyance above referred to, and was the husband and father of affiants, and was a grantor and trustee of the above-mentioned trust;

3. That by reason of the death of said DALE R. OGDEN, and pursuant to paragraph A., of Article VIII of said Trust Agreement, the affiant EDNA B. OGDEN has become the trustee of the "Marital Portion" of said Dale R. Ogden Family Trust, and the affiants STEVEN DALE OGDEN and LINDA ELIZABETH CALLAWAY have become the trustees of the "Family Portion" of said Trust;

4. That affiants do hereby accept to serve in said capacity as trustees of said Trust; and that by reason of the death of said DALE R. OGDEN, and the terms of said Trust Agreement, affiants as trustees, and with the power and authority vested in them by reason of said Trust, do allocate the below described property to the Marital Portion of said Trust Agreement as follows:

The below described property shall be allocated to the Marital Portion (i.e., EDNA B. OGDEN, trustee of the Marital Portion of the Dale R. Ogden Family Trust dated October 5, 1979).

5. That said above-mentioned real property being situate in the County of Salt Lake, State of Utah and being more particularly described as follows:

Beginning on center line of a proposed North-South Road at a point South 399.15 feet and West 202.20 feet from South Quarter Corner of Section 24, Township 2 South, Range 1 West, Salt Lake Base and Meridian, and running thence West 264.87 feet to the East right of way line of I-15 freeway; thence North 15°17'40" East 188.12 feet; thence East 215.25 feet to the center line of said proposed road, thence South 181.46 feet to point of beginning.

- 6. That title to the properties belonging to said Trust is now duly vested in affiant, EDNA B. OGDEN, as trustee, according to the allocations set forth in this affidavit, and that said Trust, incorporated herein by reference and expressly made a part hereof by this reference, is in full force and effect at this time, and that all trustee's powers enumerated therein for the administration and disposition of assets belonging to said Trust shall be exercised by said affiants, as trustees, in accordance with the terms of said Trust.
