EASEMENT NO. 1 REVISED

A 10 foot wide easement on the Southwesterly side of the following described line:

BEGINNING at a point which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 249.27 feet and N. 11° 47' 12" W., 880.30 feet from the southwest corner of Block 17, Kaysville Townsite Survey said point also being on the Easterly line of 600 North Street and thence running S. 43° 14' E., 725.46 feet to a point which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 249.27 feet and N. 43° 35' W., 459.97 feet from said Southwest Corner of Block 17.

EASEMENT NO. 2

A 10 foot wide easement, 5 feet on each side of the following described centerline:

BEGINNING at a point which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 249.27 feet and N. 22° 31' 29" W., 653.98 feet from the Southwest Corner of Block 17, Kaysville Townsite Survey said point also being on the Easterly line of 600 North Street and thence running S. 43° 14' E., 430.00 feet; thence S. 46° 46' W., 10.00 feet to a point which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 249.27 feet and N. 7° 22' 07" E., 286.32 feet from said Southwest Corner of Block 17.

EASEMENT NO. 3

A 10 foot wide easement along the Easterly side of the following described line:

BEGINNING at a point on the Northerly line of Kaysville M.S. which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 684.57 feet from the Southwest Corner of Block 17, Kaysville Townsite Survey said point also being on the Easterly line of 600 North Street and thence running along said Easterly line N. 14° 12' E., 183.64 feet to a point of tangency with a 1132.00 foot radius curve to the right (radius point bears S. 75° 48' E.); thence Northeasterly along the arc of said curve 275.94 feet to a point of tangency with a 431.36 foot radius curve to the left (radius point bears N. 61° 50' W.); thence Northeasterly along the arc of said curve 190.31 feet to a point of tangency with a 255.51 foot radius curve to the right (radius point bears S. 87° 06' 39" E.); thence Northeasterly along the arc of said curve 143.27 feet to a point which is N. 46° 25' W., 703.5 feet and N. 75° 10' W., 249.27 feet and N. 11° 47' 12" W., 880.30 feet from said Southwest Corner of Block 17.

A 10 foot wide easement on the Northeasterly side of the following described line:

BEGINNING at a point on the Northerly line of Kaysville Main Street which point is N. $46^{\circ}25'$ W., 703.5 feet and N. $75^{\circ}10'$ W., 249.27 feet from the Southwest Corner of Block 17, Kaysville Townsite Survey and thence running N. $75^{\circ}10'$ W., 435.30 feet along the Northerly line of Kaysville Main Street to a point which is N. $46^{\circ}25'$ W., 703.5 feet and N. $75^{\circ}10'$ W., 684.57 feet from said Southwest Corner of Block 17.

EASEMENT NO. 5

A 10 foot wide easement, 5 feet on each side of the following described centerline:

BEGINNING at a point which is N. $46^{\circ}25'$ W., 703.5 feet and N. $75^{\circ}10'$ W., 249.27 feet and N. $21^{\circ}20'38''$ W., 784.87 feet from the Southwest Corner of Block 17, Kaysville Townsite Survey, said point also being on the Northwesterly line of 600 North Street and running thence N. $46^{\circ}42'39''$ W., 377.39 feet to a point which is N. $46^{\circ}25'$ W., 703.5 feet and N. $75^{\circ}10'$ W., 249.27 feet and N. $29^{\circ}30'58''$ W., 1137.42 feet from said Southwest Corner of Block 17.

EASEMENT NO. 7

A 10.00 foot wide easement along the southerly side of the following described line:

Beginning at a point on the Easterly side of Kaysville 600 North Street which is N. $46^{\circ}25'00''$ W., 703.50 feet, thence N. $75^{\circ}10'00''$ W., 684.57 feet and N. $12^{\circ}00'00''$ W., 140.00 feet from the Southwest corner of Block 17, Kaysville Townsite Survey and running thence S. $75^{\circ}10'00''$ E., 262.13 feet to a point which is N. $46^{\circ}25'00''$ W., 703.50 feet and N. $75^{\circ}10'00''$ W., 423.99 feet and N. $14^{\circ}50'00''$ E., 139.99 feet from said Southwest corner Block 17.
