THIS AGREEMENT made this Second day of June, A. D. 1919 by and between Bertha Matilda Schwab, first party, and Franz Otto Drechsel and Adolph H. Knorr, second parties, all of Salt Lake City, Salt Lake County, State of Utah. WITNESSETH:

Whereas, first party is the owner of the following: - Beginning at center of Section Three (3), Township 1 South, Range 1 West, Salt Lake Meridian, and running thence West 80 rods, thence North 10 rods, thence East 85 rods, thence South 10 rods, thence West 5 rods, to the point of beginning;

And Whereas, the second parties hold a contract to purchase from Mary O. Adams, the following:- The North half of Northwest quarter of Southwest quarter of said Section 3, and the second parties desire to acquire from the first party a right of way for a water ditch over the property of the first party as the same is now located thereon.

THEREFORE, first party, in consideration of the sum of \$75.00 to her in hand paid by the second parties, the receipt whereof is hereby acknowledged, does hereby grant unto the second parties, upon the conditions hereinafter recited, a right of way for a water ditch as the same now exists upon the land of first party and described as follows, to-wit: Beginning at a point where the Brighton Irrigation Canal intersects the South line of the property of the first party above described, which point is about 400 feet East from the Southwest corner of the said property of first party and about 3 feet North from said last named point, and running thence West along or near to the South line of said property about 400 feet to the Easterly line of the railroad company's right of way, thence Southwesterly along said right of way until same leaves property of first

This conveyance is made on condition that the second parties shall not go upon the land of the first party which lies North of said ditch, but shall always keep to the South of said ditch for the purpose of maintaining the said ditch when necessary; and,

That the right herein granted shall be used with that part of the land being purchased by the second parties which lies Southeasterly from the railroad right of way which now exists upon the property of the second parties, and with no other land; and,

In case the second parties should forfeit all right, title and interest in and to the land now being purchased by them, and should not acquire the legal title thereto, then this grant shall become null and void and of no effect; but if second parties acquire such legal title then this grant shall be perpetual.
