

RIGHT OF WAY WARRANTY DEED.

WITNESSETH, That the said parties of the first part, in consideration of the sum of Two Hundred Seventy Dollars the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell warrant and convey unto the said party of the second part, its successors and assigns, all that piece, pieces, parcel and parcels of land, and all the following described real estate, privileges and rights, situated in the County of Weber and State of Utah, to-wit:

A strip and tract of land 73 feet wide, as the same is or shall be surveyed, staked and located, across and through the following tract and tracts of land, as said route of line of said railway passes through the same, to-wit:

Mer Beginning on the center line of said railway at its intersection with the south boundary of said land at a point about 374 ft. east of the east side of a highway along the west side of said section: and running thence North 1315 ft with 33 ft. on the west side and 40 ft. on the east side of said railway center line containing 2.20 acres of land.
