FIRST SUPPLEMENTAL DECLARATION OF COVENANTS,

CONDITIONS AND RESTRICTIONS OF

BLACKHAWK STATION SUBDIVISION

This First Supplemental Declaration of Covenants, Conditions and Restrictions, hereinafter referred to as the "First Supplemental Declaration" is made and executed in Summit County, State of Utah, this _____ day of ______, 1999, by MJM2 L.C., a Utah limited liability company, designated and referred to herein as "Declarant," pursuant to the provisions of the Declaration.

WITNESSETH:

WHEREAS, on September 1, 1998, the Declarant executed the original Declaration of Covenants, Conditions and Restrictions of Blackhawk Station Subdivision ("Declaration"). On September 3, 1998, Declarant simultaneously recorded with the Summit County Recorder the Declaration as Entry No. 516902 in Book 1179, Pages 553-592, and that certain record of survey map, Blackhawk Station Subdivision Phase I ("Plat I").

WHEREAS, Article 11 provides for expanding the Project as set forth in the Declaration by adding additional Lots.

WHEREAS, the Declarant is the owner of certain real property located at Blackhawk Station Subdivision, Summit County, Utah, and more particularly described on Exhibit A" attached hereto and incorporated herein by this reference ("Property").

WHEREAS, the Declarant is the owner of 80 Lots and certain other improvements heretofore constructed or hereafter to be constructed upon the Property.

WHEREAS, the Declarant desires to add as Phase II of the Project the 80 Lots, together with the Property and improvements and appurtenances thereon, to the Project as set forth in the Declaration.

WHEREAS, the 80 Lots the Declarant desires to add to the Project are set forth and depicted on that certain record of survey map, Blackhawk Station Subdivision Phase II ("Plat II") to be simultaneously recorded with this First Supplemental Declaration.

NOW, THEREFORE, the Declarant does hereby publish and declare that all of the Property depicted on Plat II, including the 80 Lots, improvements and appurtenances thereon, is held and shall be held, conveyed, hypothecated, encumbered, leased, rented, used, occupied and improved subject to the covenants, conditions, restrictions, uses, limitations and obligations set forth in the Declaration and this First Supplemental Declaration, all of which are declared and agreed to be in furtherance of a plan for the improvement of the property depicted on Plat I and Plat II and the division thereof into a subdivision and shall be deemed to run with the land and shall be a burden and a benefit to Declarant, its successors and assigns and any person or persons acquiring or owning an interest in the real property and improvements, their grantees, successors, heirs, executors, administrators, devisees, assigns, tenants, employees, and any other person who may in any manner use such property or any part thereof.

- 1. <u>Definitions</u>. All capitalized terms used in this First Supplemental Declaration, including the recitals and attachments hereof, shall have the meanings defined in the Declaration, including the recitals and attachments thereof, except for those capitalized terms specifically defined in this First Supplemental Declaration, including the recitals and attachments hereof.
- Rights and Obligations. Each of the owners of the 80 Lots added to the Project under this First Supplemental Declaration shall have all of the rights and shall be subject to each of the obligations set forth in the terms and conditions of the Declaration, Articles of Incorporation for Blackhawk Station Subdivision Owners' Association, Inc. and By-laws of Blackhawk Station Subdivision Owners' Association, Inc.
- 3. Reallocation of Undivided Interests. As required by the Declaration, the undivided interests of the Common Areas and the votes appurtenant to each of the Lots covered by the Declaration and this First Supplemental Declaration shall be reallocated among all of the Lots, including the 80 Lots added to the Project hereof. A part of the entire interest in the Common Areas shall be allocated to each Lot in proportion to the size of such Lot, and the total of the undivided interests so allocated to all of the Lots in the Project shall add up to one hundred number of square feet within such Lots and percentages of undivided interests may be rounded off. The vote shall be similarly reallocated.
- 4. Effective Date. This First Supplemental Declaration shall take effect upon recording of the First Supplemental Declaration and Plat II.
- 5. Modification. Except as expressly modified by this First Supplemental Declaration, the terms and conditions of the Declaration shall remain in full force and effect.
