WHEREAS, Loch Lomond L.L.C. made, executed and caused to be recorded, as Declarant, that certain Declaration of Covenants, Conditions and Restrictions dated May 25, 2000 and recorded among the Utah County Recorder's Office, Entry #8585, Folio 98, page 1 of 21, pursuant to which the Declarant subjected all that property described in the Declaration (the "Property") and Declarant formed an association known as, "Loch Lomond Homeowners Association" ("Association"); and

All that property described in Exhibit "A" attached hereto is annexed to the Property subject to the Declaration, and shall be held, sold and conveyed subject to the easements, declarations, covenants and conditions set forth in the Declaration, which are for the purpose of protecting the value and desirability, and enhancing the attractiveness of the Property, and which shall run with the Property and shall be binding upon all parties having any right, title or interest in the Property or any part thereof, their heirs, personal representatives, successors and assigns, and shall inure to the benefit of each owner of the Property or any part thereof and their respective heirs, personal representatives, successors and assigns, and the Association.

ALSO,

WHEREAS, pursuant to Article 2.2 (g) of the Declaration, wherein the City was recorded incorrectly as Springville City, Utah County, Declarant hereby declares that the Declaration of Covenants, Conditions and Restrictions be further amended as follows:

2. All Structures on a Lot shall be made, constructed and maintained, and all activities on a Lot shall be undertaken, in conformance with all laws and ordinances of the City of Saratoga Springs, Utah County, and State of Utah which may apply, including without limiting the generality of the foregoing, all zoning and land use ordinances.

In all other respects, the Declaration, as amended, remains unchanged.


