ABSTRACT OF FINDINGS AND ORDER

Marler, being first duly sworn, depose and say that I am the Secretary of the Salt Lake City Planning Commission (451 South State Street, #406), and that on the 20th day of May, 1993, Case No. 420-024 by Salt Lake County was heard by the Planning Commission. The applicant requested a conditional use for a parking lot in a Commercial "C-4" zoning district located at 245 West 100 South.
