- A. Declarant (or its affiliate or predecessor in interest) has previously executed and recorded that certain *Amended and Restated Declaration of Condominium for Rockwell Ranch Condominiums* (the "**Declaration**"). The Declaration was recorded in the real property records of Utah County, Utah, on October 20, 2020, as Entry No. 164122:2020 against the real property identified in the Declaration. Unless otherwise indicated, capitalized terms used herein shall have the meanings provided in the Declaration.
- B.
