- C. Trustor shall keep the Property in good condition and repair, not remove or demolish any building thereon, and complete or restore promptly and in good and workmanlike manner any building which may be constructed, damaged, or destroyed thereon. Trustor shall comply with all laws, covenants and restrictions affecting the Property, not commit or permit waste thereof, not commit, suffer, or permit any act upon the Property in violation of law, and do all other acts which from the character or use of the Property may be reasonably necessary, the specific enumerations herein not excluding the general. H. Should Trustor fail to make any payment or do any act as herein provided, the Beneficiary or Trustee, but without any obligation to do so, and without the need for prior notice to or demand upon Trustor, and without releasing Trustor from any obligation hereof, may: make or do the same in such manner and to such extent as either may deem necessary to protect the security hereof, Beneficiary or Trustee being authorized to enter upon the Property for such purposes; commence, appear in and defend any action or proceeding purporting to affect the security hereof or the rights or powers of Beneficiary or Trustee; pay, purchase, contest, or compromise any encumbrance, charge or lien which in the sole discretionary judgment of either appear to be prior or superior hereto; and in exercising any such powers, incur any liability, expend whatever amounts in their absolute discretion they may deem necessary thereof, including costs of evidence of title, employ counsel, and pay his attorney fees.

I. Trustor shall pay immediately and without demand all sums expended hereunder by Beneficiary or Trustee, with interest from date of expenditure at the rate of eighteen percent (18%), compounded monthly, beginning on the date that such cost or expense is incurred, and continuing thereafter until paid in full, and the repayment thereof shall be secured hereby.

IT IS HEREBY MUTUALLY AGREED AS FOLLOWS:

- 1. Should the Property or any part thereof be taken or damaged by reason of any public improvement or condemnation proceeding, or damaged by fire, or earthquake or in any other manner, Beneficiary shall be entitled to all compensation, awards, and other payments or relief therefor to the extent of the outstanding obligations of Trustor to Beneficiary hereunder, and shall be entitled at Beneficiary's option to commence, appear in and prosecute in its own name, any action or proceedings, or to make any compromise or settlement, in connection with such taking or damage. All such compensation, awards, damages, rights of action and proceeds, including the proceeds of any policies of fire and other insurance affecting the Property, are hereby assigned to Beneficiary, who may, after deducting therefrom all of its expenses, including attorney fees, apply the same on any indebtedness secured hereby. Trustor agrees to execute such further assignments of any compensation, award, damages, and rights of action and proceeds as Beneficiary or Trustee may require.
- 2. At any time and from time to time upon the written request of Beneficiary, payment of its fees and presentation of this Trust Deed and the Notes for endorsements (in case of full reconveyance, for cancellation and retention), without affecting the liability of any person for the payment of the indebtedness secured hereby, the Trustee may: consent to the making of any map or plat of the Property; join in granting any easement or creating any restriction thereon; join in any subordination or other agreement affecting this Trust Deed or the lien or charge thereof; reconvey, without warranty, all or any part of the Property. The grantee in any reconveyance may be described as "the person or persons entitled thereto," and the recitals therein of any matters or facts shall be conclusive proof of the truthfulness thereof. (a) Until Trustor shall default in the payment of any indebtedness secured hereby or in the performance of any agreement hereunder, Trustor shall have the right to collect all such rents, issues, royalties, and profits earned prior to default as they become due and payable.

- (b) If Trustor shall default, Trustor's right to collect any such moneys shall cease and Beneficiary shall have the right, but in no event the obligation, with or without taking possession of the Property, to collect all rents, royalties, issues, and profits, including, but not necessarily limited to, the right, power and authority, but in no event the obligation, of Beneficiary to enter into new leases and agreements with respect to the Property in an attempt to maximize the revenue to be generated and collected from the Property, and to employ such property managers and/or other agents as may be appropriate to facilitate the same, all at the expense of Trustor to be paid on the same terms as any other payment made by Beneficiary on behalf of Trustor and/or the Property pursuant to this Trust Deed.

Upon the transfer or conveyance of all or any fractional interest in the Property, but excepting those transfers expressly permitted as set forth more fully in the Notes, Beneficiary shall have the unrestricted right to accelerate all payments to be made pursuant to the Notes, including, without limitation, outstanding interest and principal, demand that this Notes be immediately paid in full, and Beneficiary shall have the option to foreclose this Trust Deed by judicial or non-judicial sale or in the manner provided by law for the foreclosure of mortgages on real property. Beneficiary may elect to demand payment in full of the Notes and foreclose this Trust Deed at any time subsequent to any such transfer, and no delay on the part of Beneficiary in making such demand shall act as a waiver of Beneficiary's right to demand payment in full and commence foreclosure proceedings at some future point in time.
- 11. Any forbearance by Beneficiary or Trustee in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy hereunder. Likewise, the waiver by Beneficiary or Trustee of any default of Trustor under this Trust Deed shall not be deemed to be a waiver of any other or similar defaults subsequently occurring.

Should any litigation or other proceeding be commenced by Beneficiary or Trustee against Trustor arising from this Trust Deed, to enforce this Trust Deed, or concerning the rights or duties of any party under this Trust Deed, in addition to any other relief which may be granted, the prevailing party shall be entitled to recover its reasonable costs and attorney fees incurred therein.

No amendment, waiver, change, or other modification of this Trust Deed (including, without limitation, any purported waiver as a result of the passage of time, any purported course of dealing between any of the parties, any purported oral agreement, or in any other manner whatsoever) shall be valid unless in writing, signed by both Trustor and Beneficiary (or their successors in interest) and expressly stating that the parties specifically intended to amend, change, or otherwise modify this Trust Deed thereby.


