FIRST AMENDMENT TO THE
DECLARATION OF PROTECTIVE COVENANTS AND RESTRICTIONS
APPLYING TO UNIVERSITY GARDENS SUBDIVISION, PLAT B
PROVO CITY, UTAH

WHEREAS, the original DECLARATION OF PROTECTIVE COVENANTS AND RESTRICTIONS APPLYING TO UNIVERSITY GARDENS SUBDIVISION, PLAT B, PROVO CITY, UTAH, ("Restrictions and Covenants") was signed August 6, 1943, and recorded in the office of the Utah County Recorder on August 18, 1943, as entry number 8809, in book 377, at pages 634 and 635, and

WHEREAS, as stated in the Restrictions and Covenants, the owners of the lots have authority to change the Restrictions and Covenants in whole or in part by majority vote after January, 1969, and

WHEREAS, section "I" of the Restrictions and Covenants reads as follows:

I No person who is of any race other than the white race shall use or occupy any building or any lot, except that this covenant shall not prevent occupancy by domestic servants of a different race domiciled with an owner or tenant.

NOW, THEREFORE: The signers hereto, as a majority of the present lot owners of University Gardens Subdivision, Plat B, do hereby mutually and severally agree to amend the Restrictions and Covenants as follows:

Section "I" of said covenant is hereby deleted and removed in its entirety.
