Located in East ½ of section 19, Township 1 South, Range 4 East, Salt Lake Base & Meridian Beginning at the point of intersection of the southerly right-of-way line of I-80 and the East section line of said Section 19, this point being 1526.0 feet south more or less, along the east section line form the North East corner of Section 19; thence along the East section line South 01 degree 02' 08" East 63.44 feet; thence North 72 degree 05' 00" West 2332.51 feet; thence North 72 degree 16' 00" West 306.61 feet; thence North 70 degree 15' 00" West 159.04 feet; thence to a point on an existing fence line, said fence line being the boundary line described in that certain boundary line agreement dated July 27, 1994, recorded as Entry number 00410754, Book 823, Page 798-804 in the office of the Summit County Recorder, Summit County, Utah; thence along said boundary line North 00 degree 18' 50" West 63.88 feet more or less to a point on the southerly right-of-way line of I-80; thence along said right-of-way line through the following 3 courses (1) South 70 degree 15' 00" East 179.90 feet; (2) thence South 72degree 16' 00" East 305.65 feet; (3) thence South 72degree 05'00" East 2312.00 feet to the point of beginning.
