The installed pipeline begins at 8900 South Wasatch Boulevard with a valve pit and valving assembly shown on drawing No. 15457 Sheet 2 and shown in drawing No. 15465 Sheet 1. From this valve pit the 8 inch pipeline runs under the east shoulder of State Highway 210 until a point where the pipeline crosses liighway 210 to the west side of State Highway 210 as shown on drawing No. 15467 Sheet 4. The pipeline continues under the south and south west shoulder of State Highway 210 and crosses under then continues under the south shoulder and south portions of State Highway 210 in Little Cottonwood Canyon. The pipeline continues to a block valve assembly and valve pit slown on drawing No. 15467 Sheet 12 and shown on drawing No. 15466 Sheet 1. From the block valve assembly and valve pit the pipeline continues under the south shoulder and south portion of State Highway 210.
