DAVID C. JOHNSON, STEVEN RUNOLFSON, MARK HAUG and MANNING GURIAN,  
Grantors, of Salt Lake County, State of Utah, do hereby convey and warrant to MOUNTAIN  
FUEL SUPPLY COMPANY, a corporation of the State of Utah, Grantee, its successors and  
assigns, for the sum of ONE DOLLAR (\$1.00) and other good and valuable consideration,  
receipt of which is hereby acknowledged, a right-of-way and easement to lay, maintain, operate,  
repair, inspect, protect, remove and replace pipelines, valves, valve boxes and other gas  
transmission and distribution facilities (hereinafter collectively called "facilities"), said right-of-  
way being situated in the County of Salt Lake, State of Utah, and more particularly described  
as follows, to-wit:

Beginning at a point located on Grantors' East property line which is North  
637.75 feet and East 1768.18 feet from the West Quarter corner of Section 12,  
Township 3 South, Range 1 East, Salt Lake Base and Meridian; thence North  
85°43'24" West 25.00 Feet, thence North 3°00'00" East 189.99 Feet, thence  
North 60°50'35" West 44.63 feet; thence North 86°00'00" West 157.87 feet;  
thence North 19°08'32" West 91.80 feet; thence North 76°05'12" West 54.71  
feet; thence North 13°54'59" East 16.00 feet; thence South 76°05'12" East 63.42  
feet; thence South 19°08'32" East 89.92 feet; thence South 86°00'00" East  
150.87 feet; thence South 60°50'35" East 68.16 feet; thence South 03°00'00"  
West 196.10 feet to the point of beginning;

TO HAVE AND TO HOLD the same unto said Mountain Fuel Supply Company, its successors  
and assigns, so long as such facilities shall be maintained, with the right of ingress and egress  
to and from said right-of-way to maintain, operate, repair, inspect, protect, remove and replace  
the same. During temporary periods, Grantee may use such portion of the property along and  
adjacent to said right-of-way as may be reasonably necessary in connection with construction,  
maintenance, repair, removal or replacement of the facilities. Grantors shall have the right to  
use said premises except for the purposes for which this right-of-way and easement is granted  
to Grantee, provided such use does not interfere with the facilities or any other rights granted  
to Grantee hereunder.

assigned in whole or in part by Grantee.

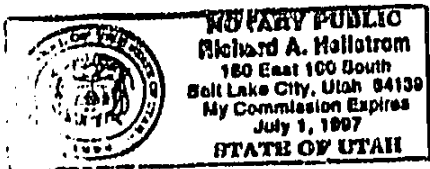

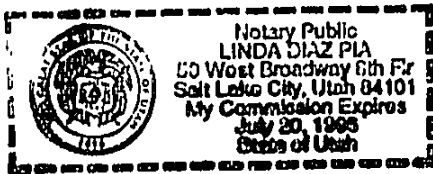
