THIRD AMENDMENT TO DECLARATION

OF "THE AVENUE CONDOMINIUMS"

A CONDOMINIUM PROJECT

This Third Amendment to Declaration of the Avenue Condominium, a Condominium Project, containing covenants, conditions and restrictions relating to The Avenue Condominium, A Condominium Project, is made on the date set forth at the end hereof by Alexandra Development, Inc., a Utah Corporation, hereinafter called "Declarant", for itself, its successors, grantees and assigns, pursuant to the Condominium Ownership Act of the State of Utah.

RECITALS

A. This Third Amendment to the Declaration of The Avenue Condominiums is intended to and shall affect only those specific provisions of the Declaration as are referred to hereafter. The original Declaration herein amended was recorded January 22, 1990, as Entry No. 2033 at Book 2659, Pages 823-853. All provisions of the Declaration not specifically amended herein shall remain in full force and effect.

This amendment is made pursuant to 57-8-13.6 UCA 1953 as amended for the purpose of creating 12 additional units on a portion of the "expandable property" as provided in the original declaration. Concurrent herewith a supplemental "Record of survey map" is recorded.

B. The legal description is amended to include the following real property:

Commencing at a point which is South 608.75 and West 502.37 feet from the Northeast corner of Section 1,

Township 7 South, Range 2 East, Salt Lake Base and Meridian; thence as follows: North 01 deg.00'00" East 155.40 feet along East line of University Avenue; thence 5.88 deg. 49'20" East 274.82 feet; thence 5.01 deg. 07'08" West 165.39 feet along West line of 50 East Street; thence North 88 deg. 49'20" West 110.38 feet; thence North 00 deg. 06'02" East 10.00 feet; thence North 88 deg. 49'20" West 163.94 feet to the point of beginning.

C. Paragraph 2 is amended to include a portion of the expandable property within the declaration.

D. Paragraphs 3, 4, and 9 are amended to include two additional residential buildings with 12 additional units for a total of 42 units.

E. Third Amended Exhibit A designating each individual unit, its square footage and common space ownership is attached hereto and incorporated herein.

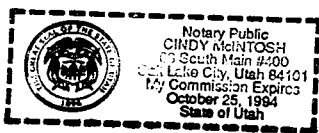

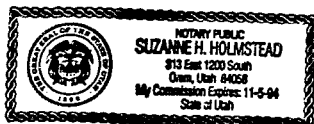
