C. This amendment is being made pursuant to the power granted to the Declarant to unilaterally amend the Master Declaration as found in Article II, Section 1(b) and Article XXIII, Section 3, of the Master Declaration.

D. Declarant shall cause this amendment to be recorded in the Official Record of the Washington County Recorder's Office and added to the original Master Declaration as a fully integrated and incorporated Amendment to said Master Declaration.

NOW, IHERPHORI for the foregoing purposes. Declarant hereby amends Article XVI,
Section 1. Master Association Maintenance of the Master Declaration as follows.

ARTICLE XVI MAINTENANCE RESPONSIBILITIES

Section 1 Master Association Maintenance. The Master Association shall maintain, repair and replace the Master Association property and all improvements thereon. In addition the Master Association shall maintain the landscaping within the medians, islands, and sidewalk areas of the public streets in certain portions of the Sunbrook area, which area is set forth in the legal descriptions of the Master Declaration. Specifically the Master Association shall maintain the landscaping on that portion of Sunbrook Drive beginning at the intersection of Sunbrook. Drive and I meraud Drive and continuing westward on Sunbrook Drive, including the other public streets int the Sunbrook Area. I andscape maintenance does not include maintenance of the asphalt roads, curbs and gutters, and/or the sidewalks. The Master Association shall not however, maintain the landscaping on that portion of Sunbrook Drive starting at Dixic Drive and continuing westward to Fineraud Drive.
