MEMORANDUM OF OPTION AND DEVELOPMENT AGREEMENT (P2 Property)

This MEMORANDUM OF OPTION AND DEVELOPMENT AGREEMENT (the "Memorandum") is entered into as of October 31, 2022, by and between Western Acres – Tooele City, L.P., a Delaware limited partnership ("Owner"), and D.R. Horton, Inc., a Delaware corporation ("Builder").

- 3. <u>No Alteration of Option Agreement</u>. This Memorandum is subject to the terms, covenants, conditions and provisions of the Option Agreement and is not intended and shall not be construed to alter, modify, limit, abridge or enlarge any of the terms, covenants, conditions or provisions of the Option Agreement.
- 4. <u>Termination</u>. This Memorandum shall automatically terminate and be of no further force or effect with respect to (A) any dwelling unit constructed on the Property for which a certificate of occupancy has been obtained, concurrently with the conveyance of such dwelling unit to a purchaser of such dwelling unit, and (B) any portion of the Property (or interest therein) that is conveyed to the City of Tooele, any other governmental or quasi-governmental authority, a utility company, or any homeowner's association. Notwithstanding such automatic release, Owner agrees to provide any applicable release within five (5) days of request therefor by Builder.
- 5. <u>Governing Law</u>. This Memorandum shall be governed by, and construed and enforced in accordance with, the laws of the State in which the Property is located.
