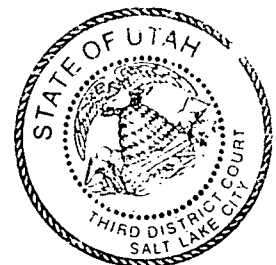
IN THIS ACTION, the Defendant Brian Middleton d/b/a Western Diesel ("Defendant"),
having been regularly served with process, and having failed to appear and answer Plaintiff's
Complaint filed herein, the legal time for answering having expired, and the default of the said
Defendant in the premises having been duly entered according to law, now upon the application
of said Plaintiff to the above-entitled Court, judgment is hereby entered against said Defendant in
pursuance of the prayer of said Complaint.

WHEREFORE, by virtue of the law, and by reason of the premises aforesaid, it is ordered, adjudged, and decreed that Plaintiff recover from said Defendant the sum of \$21,508.65, together with interest at the prejudgment rate of 24% per annum from 3/1/2015 to the date of judgment in the amount of \$1,527.41, together with Court costs and service fees in the amount of \$565.00, together with attorney's fees in the amount of \$1,144.17, for a total judgment of \$24,745.23. It is further ordered that this judgment may be augmented in the amount of interest at the rate of 24% per annum continuing from the date of this judgment until paid, and also augmented with reasonable costs and attorney fees expended in collecting said judgment by execution or otherwise as shall be established by affidavit. Pursuant to Rule 62 of the Utah Rules of Civil Procedure, the Court directs that execution on this judgment may proceed immediately.
