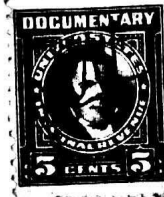

Right Of Way Deed



Joseph F. Wright (Widower) grantor
of Bigden, County of Weber, State of Utah,

hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the
(272.00) sum of Two Hundred and Seventy Two DOLLARS,

the following described right of way across the grantor's land in Weber County,
State of Utah, as follows:

Right of way for highway known as F. A. Project No. 114-E across the grantors land in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 23, T. 5 N., R. 2 W., S. L. M. Said right of way is contained within a parcel of land 50 ft. wide, 50 ft. on the west side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the south boundary line produced of said grantors land and said center line of survey at Engineer's Station 418+94.5, which point is 320 ft. south along the east line of said Section 23, from the northeast corner of said Section 23; thence N. 0°10' E., 320 ft. to the intersection of said center line of survey at Engineer's Station 422+14.5 and the north line of said Section 23, which point is also the northeast corner of said Section 23, as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described parcel of land contains 0.37 acre, of which 0.30 acre is now occupied by the existing highway. Balance 0.07 acre.

In executing this deed, the grantor hereby grants to the State Road Commission of Utah permission to relocate and reconstruct within the grantors land and outside the limits of above described right of way, all irrigation ditches existing within said limits of above described right of way and to extend onto said grantors land and outside the limits of the above described right of way all cut and/or fill slopes made necessary by the grading for sidewalks on said project.

The purpose of this deed is to grant a perpetual right of way for highway purposes.

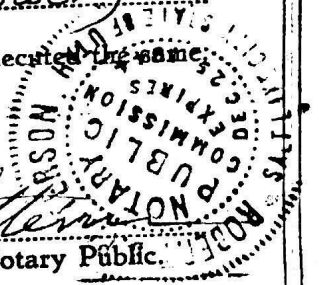
