AN ORDINANCE AMENDING TITLE 19, ENTITLED "ZONING" OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 1986, BY CHANGING CERTAIN PROPERTIES IN SALT LAKE COUNTY FROM RESIDENTIAL ZONE A-1 TO A-1/ZC AND R-1-6 TO R-1-8 OR R-1-10

The Board of County Commissioners of the County of Salt Lake ordains as follows:

SECTION I. Section 19.06.020, of the Salt Lake County Code of Ordinances, 1986, entitled "Zoning" is hereby amended as follows:

The Properties in Magna described by map in application #PL-94-4074 filed by the Salt Lake County Planning Commission, are hereby reclassified in the following manner shown on the map titled Magna Area Rezoning PL-94-4074, dated October 1994. The properties are located generally within the following areas:

From an A-1 zone to an A-1/zc zone. Zoning condition excludes the uses of duplexes and dwelling groups:

- * Between 7200 W. and 9180 W. &
2400 So. to 3100 So.

(All properties currently zoned A-1 to A-1/zc)

- * Between 8400 W. and 8900 W. &
3500 So. to the D & RGW railroad

(All properties currently zoned A-1 to A-1/zc)

From a residential single-family zone R-1-6 to an R-1-8 or R-1-10 zone.

- * Between 8550 W. and the D & RGW railroad &
3250 So. to 3500 So.

(All properties currently zoned R-1-6 to R-1-8)

- * Between 7495 W. and 7895 W. &
3500 So. to 3800 So.

(All properties currently zoned R-1-6 to R-1-10)

SECTION II. The map showing such change shall be filed with the Salt Lake County Planning Commission on accordance with Section 19.06.020 of the Salt Lake

SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication a newspaper published and having general circulation Salt Lake County.


