RIGHT-OF-WAY AND EASEMENT GRANT

Beginning at a point located on Grantors' West property line, said point being the East right-of-way line of Redwood Road, said point being South 2566.89 feet and East 40.83 feet from the North Quarter Corner of Section 22, Township 2 South, Range 1 West, Salt Lake Base and Meridian and running thence North 0°3'0" East 16.02 feet; thence South 87°0'0" East 202.85 feet; thence South 88°36'21" East 299.48 feet; thence South 16.00 feet; thence North 88°36'21" West 300.09 feet; thence North 87°0'0" West 202.25 feet to the point of beginning;

TO HAVE AND TO HOLD the same unto said Mountain Fuel Supply Company, its successors and assigns, so long as such facilities shall be maintained; with the right of ingress and egress to and from said right-of-way to maintain, operate, repair, inspect, protect, remove and replace the same. During temporary periods, Grantee may use such portion of the property along and adjacent to said right-of-way as may be reasonably-necessary in connection with construction, maintenance, repair, removal or replacement of the facilities. Grantors shall have the right to use said premises except for the purposes for which this right-of-way and easement is granted to Grantee, provided such use does not interfere with the facilities or any other rights granted to Grantee hereunder.

Grantors shall not build or construct, nor permit to be built or constructed, any building or other improvement over or across said right-of-way, nor change the contour thereof, without written consent of Grantee.
