CONVEYANCE OF PROPERTY AND EASEMENTS

- 1. All of said Grantor's right and title to the use of water from Harper Spring, located in Harper Ward, Box Elder County, Utah. The point of diversion therefrom being located South 556.5 feet and West 199 feet from the NE Corner of Section 22, T10N, R2W, SLB&M; said water right being evidenced by recognized diligence use.
- 2. An easement with right of ingress and egress thereto and therefrom, for the construction, operation and maintenance of a concrete-lined canal for irrigation purposes with the right to install structures, weirs, and appurtenant works adjacent thereto, said right-of-way being described as follows:

A canal beginning at a point on Harper Spring Channel, located South 556.5 feet and West 199 feet from the Northeast Corner of Section 22, TlON, R2W, and running Southeasterly along the existing canal for a distance of 5590 feet, more or less, also a head ditch beginning at a point 199 feet West, more or less, from the Northeast Corner of Section 22, and running in a Northwesterly direction along the existing canal for a distance of 2530.0 feet, more or less.

3. The right to the full use of the irrigation company's distribution system now used to irrigate land in the East $\frac{1}{2}$ of the NE $\frac{1}{4}$, and the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 22; the NW $\frac{1}{4}$ of Section 23; and the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 26, all of T10N, R2W, SLB&M.
