

ORDINANCE

AN ORDINANCE AMENDING TITLE XIX, ENTITLED "ZONING" OF THE SALT LAKE COUNTY CODE OF ORDINANCE, 1986, BY CHANGING CERTAIN PROPERTY IN SALT LAKE COUNTY FROM RESIDENTIAL ZONES R-1-8 AND R-1-10 TO R-1-10 AND R-1-21/zc.

The board of county commissioners of the County of Salt Lake ordains as follows:

SECTION I. Section 19.06.020, of the Salt Lake County Code of Ordinances, 1986, entitled "Zoning map" is hereby amended as follows:

The properties described by map in Application #PL-95-4023 filed by the Salt Lake County Planning Commission, are hereby reclassified from Residential Zones R-1-8 and R-1-10 to R-1-10 and R-1-21/zc, in the manner shown on the map titled, Mt. Olympus Cove Proposed Zoning, dated June 13, 1995.

The properties are bounded as follows; Millcreek Canyon Road (3800 South) on the north; Wasatch Boulevard (approximately 3320 East) on the West; approximately 5000 South on the South; and along the eastern edge of the developed properties in Mt. Olympus Cove on the east.

Pursuant to Section 19.90.060 of the Salt Lake County, Code of Ordinances, 1986, development of property is subject to the following conditions:

- 1. Limit animals to household pets.

SECTION II. The map showing such change shall be filed with the Salt Lake County Planning Commission in accordance with Section 19.06.020 of the Salt Lake County Code of ordinances, 1986.

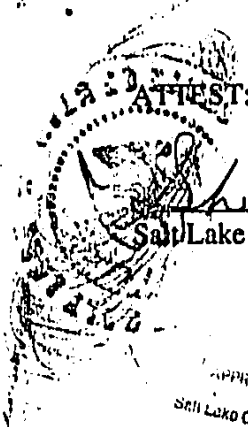
SECTION III. This ordinance shall become effective fifteen (15) days after its passage and upon at least one publication in a newspaper published and having general circulation in Salt Lake County.
