# CROSS ACCESS/PARKING AGREEMENT

This agreement, made and entered into this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_\_ 2005, by and between American Fork Medical Center and American Fork Medical Properties, LLC is based on the following:

### RECITALS

WHEREAS, parties are owners of adjacent properties identified on attachment hereto (Exhibit A).

NOW, THEREFORE, the parties covenant and agree as follows:

- SECTION 1. Use of parking stalls located on either party's property by patients, patrons, employees, vendors, etc., associated with either party.
- SECTION 2. Ingress and egress through the parking areas of either party by patients, patrons, employees, vendors, etc., associated with either party.
- SECTION 3. Access via the property of either party by solid waste removal vehicles for the benefit of either party.
- SECTION 4. Allow water runoff from the property of either party into the storm drainage system of either party.
- SECTION 5. Both parties acknowledge as indicated on the attached site plan that there are 17 parking stalls on the common property line. To satisfy American Fork City requirements all seventeen stalls are assigned to the new building owned by American Fork Medical Properties, LLC.
- SECTION 6. This agreement constitutes the entire agreement between the parties and will remain in effect in perpetuity, and this agreement shall bind the heirs, assigns and successors in interest of the respective parties. This easement shall not be released without the written consent of American Fork City.
- SECTION 7. If any party shall breach this Agreement, the other party shall be entitled to recover their attorney's fees and court costs in addition to other lawful damages resulting therefrom.
