<u>CANAL EASEMENT AGREEMENT</u> (Kennecott Utah Copper Corporation)

This Canal Easement Agreement (the "Agreement") is hereby made and entered into as of the 30 day of January, 1996, by and between BENEFICIAL DEVELOPMENT COMPANY, a Utah Corporation ("BDC") and KENNECOTT UTAH COPPER CORPORATION, a Delaware corporation ("Kennecott").

Recitals:

- A. "ursuant to a quit-claim deed (the "Deed") dated No.6211172, in Book _____, at Page _____, of the official records of the Salt Lake County Recorder, Kennecott deeded to Beneficial Development Company, a Utah corporation ("BDC"), a certain tract of land (the "Canal Lands") in Salt Lake County, State of Utah.
- B. The Canal Lands are located in Salt Lake County, State of Utah, and are more particularly described in Exhibit A which is attached hereto and by this reference made a part hereof.
- C. The Riter Canal and the Kennecott Canal (collectively the "Canal") are located on the Canal Lands.
- D. BDC has agreed to grant Kennecott an easement to use the Canal.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, BDC and Kennecott agree as follows:

1. Grant of Easement. BDC hereby quitclaims to Kennecott a perpetual, nonexclusive easement (the "Canal Easement"): (a) to use the Canal for the open channel transportation of water across the Canal Lands, and (b) to enter onto the Canal Lands for the purpose of inspecting and maintaining the Canal. The right to enter onto the Canal Lands for the purpose of maintaining the Canal does not impose any duty of maintenance on Kennecott to do so.

- 3. Amendments. No amendment, waiver, or modification of the terms and provisions contained in this Agreement shall be valid or binding unless in writing and executed by the party to be bound thereby.
- 4. <u>Severability</u>. If any provision of this Agreement shall be held invalid, illegal, or unenforceable, it shall not affect or impair the validity, legality, or enforceability of any other provision of this Agreement, and there shall be substituted for the affected provision a valid and enforceable provision as similar as possible to the affected provision.
- 5. <u>Binding Effect</u>. This Agreement shall be binding upon and inure to the benefit of BDC and Kennecott, and their successors and assigns.
- 6. <u>Captions</u>. All headings and captions used herein are for convenience only and are of no meaning in the interpretation or effect of this Agreement.
- 7. Applicable Law. This agreement shall be interpreted and enforced according to the laws of the State of Utah.

IN WITNESS WHEREOF, BDC and Kennecott have executed this Agreement.
