WHEREAS, on the 18th day of May, 1910, in the above entitled cause of action, a certain judgment of condemnation was entered by said Court, and filed herein in accordance with the agreement of the parties hereto, in which said judgment it was ordered and adjudged that upon the payment of the sum of \$50.00 to the Defendant Mary O'Donnell, or to the Clerk of this Court for her, final order of condemnation in

favor of plaintiff and against the said defendant will be entered herein as provided by law and as prayed for in the Amended Complaint in this action.

NOW, THEREFORE, it appearing to the Court that said sum has been by said plaintiff paid to the Clerk of this Court for the said defendant, Mary o'Donnell

IT IS NOW ORDERED AND ADJUDGED that the premises described in said Judgment, situate in Weber County, Utah, to-wit:

A part of the South one-half (1/2) of the southeast quarter of Section 1, Township 5 North, Range 2 West, Salt Lake Meridian, U. S. Survey; Beginning at the Southeast corner of said Section and running thence north 442.9 feet; thence south 38° 15' West 564 feet to the Section line; thence east 349.1 feet to beginning, containing 1.545 acres, but from which said area there is to be deducted 0.198 acres contained within a certain highway over and across said south half of the southeast quarter of said Section 1, near the southeast corner thereof, and which highway is southeasterly of the center line of plaintiff's railway. The net area of defendant's premises which the plaintiff actually takes is 1.347 acres,
