RODNEY T. CLARK and KAY J. CLARK, TRUSTEES of the RODNEY CLARK and KAY CLARK FAMILY TRUST,

of Pocetello, State of Idaho, grantee, the following described tract of land in Salt Lake County, State of Utah:
