# BOUNDARY LINE AGREEMENT (Fence)

WHEREAS, the Parties of the Second part are in possession of certain parcels of land adjoining and contiguous to the parcel above described and lying immediately adjacent to the fence line of the same, and to the North, East and West.

WHEREAS, the hereinabove described existing fence line separates the parcels of land and constitutes physical boundary and division line between the same that has long been recognized by the parties hereto and their predecessors in title as the boundary and division lines between their said parcels of land.

THE PARTIES AGREE THAT the established fence line as the same now exists shall constitute the boundary and division line between the said parcel of land in the possession of the parties hereto. 

BENCH, husband and wife, as joint tenants, Parties of the First Part, as their interests appear herein, any and all right, title and interest which said Parties of the Second Part may have in and to all the land in the possession of the said Parties of the First Part, lying within the boundaries of the aforedescribed fence line, survey, being the parcel of land in possession of the said STERLING E. BENCH, TRUSTEE AND DONNA T. BENCH, TRUSTEE OF THE STERLING E. BENCH FAMILY TRUST and THOMAS R. BENCH and JANINE A. BENCH, husband and wife, as joint tenants, Parties of the First Part, hereinabove described.




