POLE LINE EASEMENT

Mrs. Emma Winter a widow, Grantor, of Salt Lake County, Utah, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alterations, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and 2 guy anchors & 11 poles, with the necessary guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor, in Salt Lake County, Utah, along a line described as follows:

Beginning on west boundary line of grantor's land at East Jordan Canal at a point 1125 ft. north and 625 ft. west, more or less, from the southeast corner of Sec. 15, T. 4 S., R. 1 W., S.L.P.M., thence running S. 53°46' E. 50 ft. thence S. 13°03' E. 1685 ft., thence S. 33° 23' E. 400 ft., more or less, to east boundary line of said land, and being in the SE 1/4 of the SE 1/4 Sec. 15 and the NE 1/4 of the NE 1/4 Sec. 22, Twp. and Range aforesaid.

Also beginning at fence on north boundary line of grantor's land at a point 1900 ft. south and 665 ft. east, more or less, from the northwest corner of Sec. 23, T. 4 S., R. 1 W., S.L.P.M., thence running S. 33°23' E. 890 ft., more or less, to south boundary line of said land and being in the SW 1/4 of the NW 1/4 said Sec. 23.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
