

Right Of Way Deed

James L. Wheelwright & Olive Blackford Wheelwright Grantors
 of 1904 County of Weber State of Utah,
 hereby grant, bargain and sell to the STATE ROAD COMMISSION OF UTAH, Grantee, for
 the sum of (50⁰⁰) Fifty 00 100 DOLLARS,
 the following described strip or parcel of land, as a perpetual right of way for highway purposes
 across the grantor's land in Weber County, State of Utah, as follows:

Right of way for highway known as F. A. Project No. 114-A across the gran-
 tors land in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 13, T. 5 N., R. 2 W., S. L. M. Said right of
 way is contained within a parcel of land 100 ft. wide, 50 ft. on each side of the
 center line of survey of said project. Said center line is described as follows:

Beginning at a point on said center line of survey at Engineer's Station
 17+00, which point is 93 ft. south and 659 ft. east from the west $\frac{1}{4}$ corner of
 said Section 13; thence N. 51°59' E., 154 ft. to the intersection of said center
 line of survey at Engineer's Station 18+54 and the north boundary line of said
 NW $\frac{1}{4}$ SW $\frac{1}{4}$, which point is 790 ft. east along said north line from said west $\frac{1}{4}$ corner
 of Section 13, as shown on the official map of said project on file in the office
 of the State Road Commission of Utah. Above described parcel of land contains
 0.35 acre, of which 0.30 acre is now occupied by the existing highway and deed
 No. 114-A-3. Balance 0.05 acre.

In executing this deed, the grantor hereby grants to the State Road Commis-
 sion of Utah permission to relocate and reconstruct within the grantors land and
 outside the limits of above described right of way, all irrigation ditches existing
 within said limits of above described right of way.

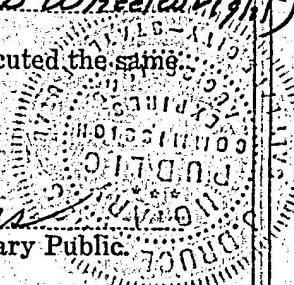
