hereby CONVEY AND WARRANT to the UTAH DEPARTMENT OF TRANSPORTATION, at  
4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum  
of Ten (\$10.00) Dollars,  
and other good and valuable considerations, the following described parcel of land  
in Salt Lake County, State of Utah, to-wit:

An undivided 68% interest in a parcel of land in fee for the reconstruction of a freeway known as  
Project No. 15-7, being part of an entire tract of property situate in the NE 1/4 NW 1/4 of Section 25,  
T. 2 S., R. 1 W., S.L.B.&M. The boundaries of said parcel of land are described as follows:

Beginning at the Southwest Corner of said entire tract at a point which is 121.662 meters south  
and 142.363 meters west from the North Quarter Corner of said Section 25; and running thence  
N. 15°17'40" E. 6.940 meters along the existing easterly right of way and no-access line of I-15 and  
the westerly boundary line of said entire tract; thence S. 06°28'02" W. 6.737 meters to the south  
boundary line of said entire tract; thence West 1.072 meters along said south boundary line to the  
point of beginning as shown on the official map of said project on file in the office of the Utah  
Department of Transportation. The above described parcel of land contains 3.6 square meters.

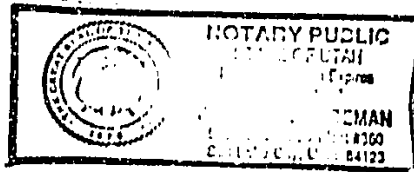
