ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Utah Non-Profit Corporations Act do certify the following under the penalties of perjury:

- 1. The name of the corporation is: RIVER PARK ESTATE HOMEOWNERS' ASSOCIATION, INC.
 - 2. The period of duration of the Corporation shall be perpetual.
 - The purposes for which the corporation is formed are as follows:
