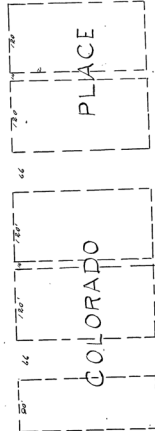
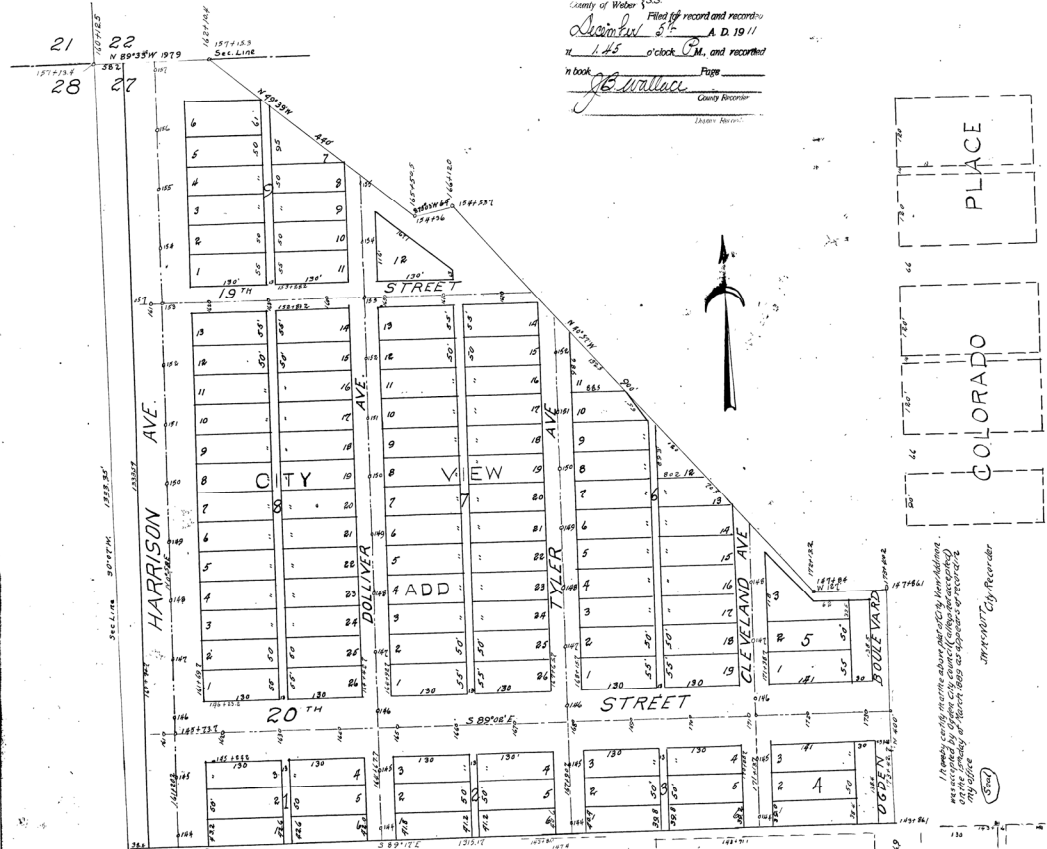

AMMENDED DEDICATION

I WILLIAM GLASSMANN the original owner of CITY VIEW ADDITION OGDEN UTAH located in the North West Quarter of the North West Quarter of Section 27 T4R10M hereby certify that I filed with the County Recorder of Weber County on the twentieth day of March, 1890 the original plat of City View Addition, and that the recorder of said County purloined the original plat as filed above, and I hereby dedicate to Ogden City all of Ogden Boulevard, Cleveland, Tyler, Dollner, and Harrison Avenues, Nineteenth and Twentieth Streets to be used as public thoroughfares forever. And the alleys running North and South through the blocks of said City View Addition all as located and described on this plat to be used in common by the Whosoever shall own any lots or parts of lots abutting thereon; the rights to the use of the Alleys being appurtenant to any and all lands fronting thereon
