AN ORDINANCE OF THE TOOELE CITY COUNCIL CHANGING THE NAME OF MARSHALL CREST STREET TO TO PINE MEADOW LANE, AND RENUMBERING THE RESIDENCES ABUTTING THEREON TO COINCIDE WITH THE CITY'S ADDRESSING GRID

WHEREAS, there is a private street in the Bickmore Planned Unit Development in Tooele City which has been known as Marshall Crest, and the residences abutting thereon have addresses which do not relate in any way to the City's addressing grid; and,

WHEREAS, there have been instances because of the noncorresponding addressing where people cannot easily locate such residences, and such addressing may jeopardize public safety and the E-911 system; and,

WHEREAS, property owners within the Bickmore PUD have petitioned this council to change the name of the street to Pine Meadow Lane and to address residences abutting thereon in accordance with the City's addressing grid; and,

WHEREAS, such petitioners have explained their concerns to local postal officials who have verbally given support to the renaming and renumbering; and,

WHEREAS, this council held a public hearing on the matter on June 15, 1994; and,

WHEREAS, the Tooele City Council has considered all comments regarding the renaming of the street and the readdressing of the buildings and finds it to be in the best interest of Tooele City and the citizens thereof to rename the street and renumber the buildings in the interest of public safety, the E-911 system and for ease in locating such street and buildings, that the renaming and renumbering will not be detrimental to the general interest, and that it should be made;

NOW, THEREFORE, BE IT ORDAINED BY THE TOOELE CITY COUNCIL that the private street in the Bickmore Planned Unit Development in Tooele City which has been known as Marshall Crest is hereby officially renamed "Pine Meadow Lane." The numbers of certain abutting buildings and residences are hereby changed to those numbers appearing on the attached map.

This Ordinance is necessary for the peace, safety and welfare of Tooele City citizens and shall become effective immediately upon passage. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

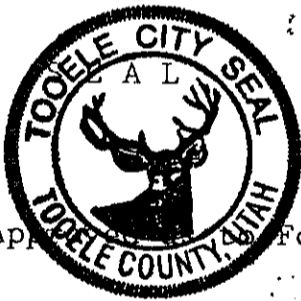
