GRANT TO USE OF WALL.

THIS INDENTURE, made this 9 day of December, 1946, between JOSEPH PIERI, an unmarried man of the Town of Milford, County of Beaver, State of Utah, grantor, to J. A. Kirk of the same place, grantee, WITNESSETH:

WHEREAS, the said grantor is the owner in fee simple of the southerly one half of Lot Eight (8) in Block Nine (9), Plat "B" Milford Townsite Survey, in the Town of Milford, County of Beaver, State of Utah, and the said grantee is the owner in fee simple of the northerly one half of said lot; and

WHEREAS, there is at present a building on the said grantor's premises, the north wall of which can be used as a party wall for any building which might be erected by the grantee hereafter;

NOW THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States, and other good and valuable consideration, paid by the said grantee to the said grantor, the receipt whereof is hereby acknowledged, the said grantor does hereby grant and convey unto the said grantee, his heirs and assigns, the right and privilege of using the said north wall of grantor's building as a party wall, provided, however, that in the grantee's use of the said wall as a party wall he shall not in any manner weaken or damage the same.

And in the event the said grantee shall at any time in the future desire so to do, he may, but solely at his expense, extend the said present wall easterly in a straight line and along the north boundary of grantor's premises and he shall thereupon have the right and privilege of using such additional wall as a party wall in the same manner as being hereby granted to him in this grant concerning the existing wall; provided, however, if said wall shall be wider than the present wall, the additional width shall be built entirely on the grantee's premises.

To hold the said easement to the said J.A. Kirk, his heirs and assigns, as appurtenant to the said land of said grantee.
