Relinquishment of Access Rights

Freeway Gardens, Inc. a Utah corporation , Grantor,
of Otem , County of Utah , State of Utah ,
being the owners of an entire tract of property, lying northerly from the existing
highway State Route 265 known as Project No.I-15-6(3)261, situate in the SE1/4 SW1/4
and the SW1/4 SE1/4 of Section 21, T.6S, R.2E., S.L.B. $\&$ M., in Utah County, Utah,
do hereby RELEASE AND RELINQUISH to the UTAH DEPARTMENT OF TRANSPORTATION at 4501
South 2700 West, Salt Lake City, Utah, 84119, Grantee, for the sum of Tex (\$10.00) Dollars, and
other good and valuable considerations, for the widening and improvement of said existing highway, being an expressway known as Project No. SP-15-6(31)270, any and all rights of access over and across the northerly right of way line of said project. Said northerly right of way line is described as follows:
Commencing 55.46 feet North and 132.63 feet West of the South Quarter Corner of Section 21, Township 6 South, Range 2 East, Salt Lake Base and Meridian; thence East 110.28 feet; thence North 60 feet; thence North 88 deg. 57' East 560.90 feet.

The Utah Department of Transportation, in consideration of the above, will provide an easement, (easement include curb and asphalt), no less than (40), feet in width, across the property to the west, (presently owned by Parkway Properties Inc., or Summit Development Inc.,), connecting the Grantors property with the dedicated Orem City street, and intersection which is on the west side of I-15 and the proposed freeway overpass. (The connecting Orem city street is also identified as the westerly extension of University Parkway.
