Received of the American Telephone and Telegraph Company Twenty seven and 50/100 Dollars, in consideration of which we hereby grant and convey unto said Company, its associated and allied companies, their respective, successors, assigns, lessees and agents, a perpetual right of way and easement to construct, reconstruct operate and maintain lines of telephone and telegraph, consisting of such poles, wires, cables, conduits guys, anchors and other fixtures and appurtenances as the grantee may from time to time require, upon across over and/or under the property which we own or in which we have any interest in the S₂N₁ Sec. 10 of T. 1 S. R 3 E. County of Summit, and State of Utah and also upon, along and/or under the roads, streets, or highways adjoining the said property, with the right to trim from time to time any trees along said lines so as to keep the wires and cables cleared at least thirty-six inches and the right to permit the attachment of and/or carry in conduit wires and cables of any other company; and with the further right to cut down and keep cut down all trees, limbs of trees and undergrowth, within 10 feet of said line. Said sum is received in full payment for the rights herein granted. It is understood and agreed that the tree cutting rights herein granted do not extend to one (1) red cedar tree now growing upon the above described property.
