SPECIAL WARRANTY DEED

THIS INSTRUMENT is executed as of the 15th day of June, 1998, by the following:

- (i) LOWELL J. CARDWELL and FERN B. CARDWELL, husband and wife (collectively, the "Cardwells"), whose address is 66 West 7440 South, Midvale, Utah 84047; and
- (ii) LOWELL J. CARDWELL, as trustee of the Lowell J. Cardwell Trust (the "Trust"), whose address is 66 West 7440 South, Midvale, Utah 84047 (the Cardwells and the Trust are collectively referred to in this Agreement as "Grantors"),

in favor of T & W INVESTMENTS, INC., a Utah corporation ("Grantee"), whose address is 8137 South State Street, Midvale, Utah 84047.

FOR THE SUM OF TEN DOLLARS (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are acknowledged, Grantors hereby convey and warrant to Grantee against all persons claiming by, through or under Grantors, but not otherwise, certain real property located in Salt Lake County, Utah, described as follows:
