RIGHT OF WAY DEED

Hyrum J. Newton and wife, Florence E. Newton grantors of Salt Lake, County of Salt Lake, State of Utah, hereby grant, bargain and sell to the STATE ROAD COMMISSION OF UTAH, Granted for the sum of Fifty & No/100 (50.00) Dollars, the following described right of way across the grantors land in Summit County, State of Utah, as follows:

Right of Way for highway known as State Route U-133 across grantors' land in the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 4 T. 2 N., R. 7 E., Salt Lake Base and Meridian. Said right of way is contained within a parcel of land described as follows:

Beginning at a point on the center line of survey of said highway at Engineers' Station 6/00, which point is N. 25 degrees 22' W., 3354.3 feet and N. 66 degrees 35' E., 568.2 feet from the Southeast corner of said section 4, Thence from said point of beginning running N. 11 degrees 41' W., 107.7 feet to a point 40.0 feet right of Engineers' station 7/00; thence N. 33 degrees 29' W., parallel to said center line, 300.0 feet to a point 40.0 feet right of Engineers' station 10/00; thence N. 45 degrees 55' W., 69.7 feet to existing fence line which is 25 feet right of Engineers' station 10/68; thence S. 22 degrees 50' E., along existing fence line 135.3 feet to a point on the center line of survey at Engineer's station 9/35; thence S. 20 degrees 15' E., along existing fence line 87.4 feet to a point 20.0 feet left of Engineer's station 8/50; thence S. 39 degrees 20' East, along existing fence line, 196.7 feet to a point on the center line of survey at engineer's station 6/55; thence S. 33 degrees 29' E 55.0 feet to point of beginning. Containing 0.4 acre.

The purpose of this deed is to grant a perpetual right of way for highway purposes.
