## TEMPORARY EASEMENT

## MONITORING WELL PIPE INFRASTRUCTURE

This Temporary Easement for Installation and Maintenance of Monitoring Well Pipe Infrastructure Agreement is entered into between The Ensign-Bickford Company, a Connecticut Corporation, 999 17<sup>th</sup> Street, 9<sup>th</sup> Floor, Denver, Colorado, 80202 (Ensign-Bickford) and Salisbury Developers, Inc, 494 West 1300 North, Springville, Utah 84663 (Salisbury) and pertains to certain real property located in the City of Mapleton, Utah County, State of Utah, more particularly described below:

See Attachment "A" attached.

WHEREAS the parties acknowledge that long-term monitoring of certain wells in the City of Mapleton is occurring by the State of Utah, specifically *Monitoring Well (MW)-1S*, which is both necessary and beneficial to the real property owned by Salisbury, and this monitoring is scheduled to continue into the future, though presumably not indefinitely, and

WHEREAS Ensign-Bickford is working with the State of Utah in performing this monitoring, and

WHEREAS it has been determined that a monitoring well pipe is necessary, specifically entitled MW-1S Pipe Infrastructure, until such time as MW-1S is no longer required, and

WHEREAS Salisbury is willing to grant a temporary easement allowing the *MW-1S Pipe Infrastructure* to be placed across its property, as described in "Exhibit A" above, under certain conditions.

THEREFORE, the parties agree and stipulate as follows:

- 1. Salisbury agrees to allow Ensign-Bickford an easement to construct and maintain that certain *MW-1S Pipe Infrastructure* across its real property described above in "Exhibit A" subject to the following conditions:
  - a. Ensign-Bickford shall be responsible for all costs involved in the construction of the *MW-1S Pipe Infrastructure* crossing Salisbury's real property and will work with Salisbury in obtaining its approval of installation timing as well as its

satisfaction in the completed installation as it regards to any disturbance of the easement area.

- b. Ensign-Bickford shall work with Salisbury in any future use or development of Salisbury's real property and shall be responsible for reimbursement of any associated costs incurred by Salisbury as it relates to the placement and maintenance of the MW-1S Pipe Infrastructure.
- 2. This Temporary Easement for Installation and Maintenance of Monitoring Well Pipe Infrastructure Agreement shall remain in force until such time as the State of Utah determines MW-1S is no longer necessary and caps or otherwise disables the well. At such time Ensign-Bickford will remove the MW-1S Well and Pipe Infrastructure, remediate the real property to its current condition, and record a release of *Temporary* Easement for Installation and Maintenance of Monitoring Well Pipe Infrastructure Agreement of this easement with the Utah County Recorder's Office.
- 3. This agreement contains all of the terms and conditions between the parties and extinguishes any prior negotiations or oral agreements. This agreement may only be amended in writing signed by each party.
- 4. This agreement runs with the land described above and the rights and obligations therein shall continue with any future owner, assign, or heir.
